



PHOTOGRAPHER CONTENT RELEASE FORM

This Photographer Content Release Agreement ("Agreement") is made between the submitting photographer ("Photographer") and Lions Art Magazine ("Magazine").

1. GRANT OF RIGHTS

The Photographer grants Lions Art Magazine a worldwide, royalty-free, perpetual and irrevocable right to use, reproduce, publish, display, distribute and archive the submitted photographs and related content in connection with Lions Art Magazine. This includes print publications, digital editions, websites, social media channels, newsletters, previews, advertising, promotional materials and future Lions Art Magazine publications or collections. Lions Art Magazine may edit, resize, crop, format or adapt the Content where necessary for publication and presentation. This Agreement does not grant Lions Art Magazine the right to sell or license individual image files to unrelated third parties for commercial image licensing purposes.

2. PHOTOGRAPHER WARRANTIES

The Photographer confirms and warrants that they are the creator and/or lawful copyright holder of the submitted Content, have full authority to grant these rights, publication does not infringe copyright, privacy rights or rights of third parties, all necessary permissions and releases have been obtained, and all persons depicted were at least 18 years old at the time of creation.

3. MODEL RIGHTS AND AGE VERIFICATION

For photographs containing recognizable persons, including nudity or partial nudity, the Photographer confirms that valid Model Releases have been obtained from every depicted person. The Photographer agrees to provide copies of valid Model Releases and age verification documents upon reasonable request by Lions Art Magazine. For content containing nudity or partial nudity, age verification documents must be available upon request.

4. FUTURE PUBLICATION AND PROMOTION

Lions Art Magazine may use selected parts of the Content for editorial presentation, website previews, social media, newsletters, advertising and promotional activities related to the Magazine.

5. COPYRIGHT AND THIRD PARTY RIGHTS

The Photographer remains the copyright owner of the submitted photographs. Lions Art Magazine receives only the publication and promotional rights granted in this Agreement.

6. INDEMNIFICATION

The Photographer agrees to defend, indemnify and hold harmless Lions Art Magazine, its publisher, representatives and affiliates from claims, damages, liabilities, costs or expenses arising from breach of this Agreement, including copyright, model rights, privacy rights or permission claims.

7. ACKNOWLEDGEMENT
